- Updated COVID-19 documents are on PSD website, and many are linked to SPC website
- First re-entry date of Oct 5th we had 15 students switch to Option 1. Still have 87 students in Option 2. November 15th is the next re-entry date.
- Occupational Health & Safety audit was conducted. SPC received very positive feedback for the great work they are doing during the pandemic
- Started the process of developing the School Development Plan (Education Plan), which is focused this year on Excellent Teaching.
- Halloween students can come to school in their costumes. No full face masks. Students must still wear their COVID masks. No parties or parents to send food.

- Replacement school update design is done. On track to break ground before the end of December. 18-24 months for the build.

- Enrollment at PSD typically see 300 student increase each year, projected a 350 increase for 2020-2021. Actual enrolment is down by 60 students from last year.
- 11,517 students enrolled. 9,764 in-class, 1,299 online, 197 Connections for Learning, 257 home eduction.
- Worksite project 17 grade 10 students are building a duplex with Covenant Homes where they attend school each day - ¹/₂ day is site work, ¹/₂ day is academics
- 2 incidents of COVID-19 in PSD since the start of the school year. Contact tracing was done, no closures required.
